INNER URGE COMPETITION 2022 REGULATIONS

The "INNER URGE COMPETITION 2022" is organised by Inner Urge Srls. It is possible to apply from 12th July 2022 (registration opening) until 30th August 2022 at 11.59 p.m. (application deadline).

Art. 1 - Conditions of participation for the selected groups

Participation in the "INNER URGE COMPETITION 2022" is open to soloists of 36 years or younger at the time of registration and to groups with an average age not exceeding 36 at the time of registration. Participants will be selected by a jury of music industry professionals. Applications must be received no later than 30th August 2022 at 11.59 p.m. (deadline for submitting applications).

Registration is open from 12th July 2022.

Participants in the "INNER URGE COMPETITION 2022" must fulfil the following conditions:

- submit original compositions of any musical genre;

- not be under contract with a record company and/or publisher (this condition applies to both soloists and group musicians);
- the lineup of musicians must be the same as in the audio files submitted for selection;

Art. 2 - The application

Each group must identify a contact person who will get in touch on behalf of the group with Inner Urge Srls. In order to apply, the group contact person must completely fill in the Google form that requires:

- the duly completed registration form (attach a copy of the valid identity document of the group contact person);

- a presentation of the group:
 - . list of musicians and their instruments;
 - . short biography complete with discography;
- . two high-resolution horizontal photos;
- a form presenting the original compositions;
- n°3 audio and/or video files of original compositions
- website link;
- link social network (FB, IG, YT).

- originality of the compositions;
- group cohesion;
- inspiration;
- quality of interpretation and arrangements;
- instrumental mastery;
- potential**;**

Art. 6 - Announcement of the winning group

The announcement of the winning groups will be made by email, through publication on the innerurgemusic.com website and through a post on Inner Urge Srls social channels. The proclamation of the results will take place at the end of the jury's evaluation.

Art. 7 - Prizes

Art. 10 - Force majeure

The entry fee for the "INNER URGE COMPETITION 2022" will not be returned for any reason whatsoever. Should the group/soloist not be selected among the winners, they will not be able to claim a refund of the entry fee.

Art. 11 - Cancellation of prizes

Failure on the part of one or more of the winners to comply with the conditions set out in Art. 1 and Art. 4 of these rules will result in the re-evaluation of the applications and the announcement of the winner(s).

Art. 12 - Applicable Law

Relations between the parties not specifically regulated in this contract shall be governed by Italian law.

Art. 13 - Competent Court

For any dispute that may arise between the parties concerning the interpretation, execution, validity and/or effectiveness of these regulations, or in any way connected with them, the Court of Bari shall have exclusive jurisdiction.

Art. 14 - Protection of privacy

The Artist declares and warrants to the Company that he/she has received from the latter an informative communication of the rights recognised to "data subjects" of personal data by the European Regulation (EU) 2016/679 (hereinafter referred to as GDPR), where such data are defined, in particular in Article 13, and that they may be exercised pursuant to and in accordance with the subsequent articles of the GDPR (General Data Protection Regulation, *note of the translator*). The Artist, insofar as may be necessary, therefore authorises the Company for the purposes of information, regulations, and administration required of the Producer in the execution of these regulations (which otherwise cannot be executed), as well as for all marketing, advertising and promotion purposes, as governed by these regulations, and more generally for the best execution of these regulations - to process the personal data of which the Artist is or will be in the future "concerned" and that have been and/or will be communicated to the Company.
